Please note the following change:

The Opening dates is changed to Tuesday August 27, 2019 at 2:00 pm due to continuing review by the City of San Antonio.

Delete the existing fee page (page 45) and replace with the attached revised pages.

The following questions are asked:

- **Question 1:** What are the parameters in which a window is acceptable to stay in place and repair or needs to be replaced completely? What I think could be repaired, the owner/architect may think needs to be replaced. Typically the architect provides a window schedule that indicated the scope of work to be done at every window, which also keeps everybody bidding the same scope of work.
- **Answer 1:** During the site walk-through on July 10, 2019 from 1-4pm; the contractors were responsible for identifying which windows needed to be repaired or perhaps replaced. To reiterate.
 - If the windows/ frames are operable, and the glass is the only item that needs to be replaced. The contractor can choose to replace just the glass and let the windows/ frame to remain.
 - If the windows are not operable, windows are removed, or the window sashes/jambs are damaged to where repairs outweighs the cost of replacement. Then the window/windows are to be replaced.
 - If the windows framing (heads, jambs or sills) need to be replaced, contractor is to ensure these portions are also replaced and properly waterproofed.

All windows are to be properly waterproofed. Windows located within 24" of a door jamb will need to be tempered.
