Item 4: Update and discussion regarding the Community Development Initiatives Quarterly Report Ms. Susan Ramos-Sossaman, Assistant Director of Community Development Initiatives, provided a summary of the department's major accomplishments and activities through the first and second guarter of fiscal year 2018-2019.

## Item 5: Update and discussion regarding the Community Development Initiatives Program Success Stories

Ms. Ramos-Sossaman reported that while the CDI Department is proud of the progress of the various metrics, it is important to note some of the success stories of our residents. Residents, Jessica Zavala and Holly Prater, were recognized during the meeting for their accomplishments and were happy to share their respective success stories with the Commissioners.

After the update and discussion of the Community Development Initiatives Program Success Stories, Commissioner McClure requested an early engagement report for seniors.

## Item 6: Update and discussion regarding the ConnectHome/Older Adults Technology Services Partnership

Ms. Ramos-Sossaman reported that in an effort to continue to expand services through the ConnectHome Program, SAHA partnered with Older Adults Technology Services (OATS), which is a nonprofit organization from New York that works to harness the power of technology to change the way we age. Ms. Ramos-Sossaman then introduced Ms. Munirih Jester, ConnectHome Coordinator, who explained the ConnectHome program and reported that OATS supplements the program by going one step further and creating more opportunities that are specific to seniors; including working in small groups to further engage with technology in order to combat social isolation and to boost health outcomes. Ms. Jester also reported that the new program will be rolled out at the following senior communities: W.C. White, Springview, O.P. Schnabel and Madonna.

Mr. Daryl Greed, a representative with OATS, was on hand to explain how the organization teaches seniors how to use mainstream devices and applications that are popular among all age groups in order to promote integration and relevance. Mr. Greed was also able to assist and answer questions that Commissioner Kaplan and Commissioner McClure had regarding the curriculum.

#### SUMMARY:

The Community Development Initiatives Department's (CDI) work is largely focused on fulfilling SAHA's first strategic goal to "empower and equip families to improve their quality of life and achieve economic stability." To accomplish this, staff works to provide services onsite and to offer opportunities to create a sense of place and community.

One of the objectives is to keep residents engaged and build leadership capacity. This not only helps facilitate better community relations, but it also helps keep SAHA accountable to its clients.

Other Housing Authorities have successfully built capacity amongst residents and have a very active leadership presence at their Housing Authority meetings, beyond the representation of a Housing Authority's Board of Commissioners. In March of 2017, in an effort to build upon a current infrastructure of meeting and training for existing Resident Councils, CDI proposed to begin to meet with the Presidents of the Resident Councils to engage them at a higher level. The intent is to meet on a quarterly basis to discuss common issues and concerns and to have the Presidents take an active role in brainstorming best solutions to resolve common problems. In addition, the efforts are intended to grow Resident Councils, increase the impact of Resident Councils, sustain active Resident Councils and facilitate collaboration with SAHA departments.

The Presidents participated in the "Good Neighbor" Campaign Trainings and presented at the Resident Services Committee meeting in September 2018. In January 2019, SAHA hosted the Presidents and Secretaries of the Resident Councils to conduct an overview of Resident Council 2018 activities. Specifically, they were tasked with outlining their 2018, challenges and successes as well as their plans for 2019.

Some of the challenges that the Presidents and Secretaries outlined included resident involvement, recruitment, working as a group, and attendance.

Some of the successes included celebrations every month, monthly birthdays, Thanksgiving Dinner, Christmas Dinner, New Year's Eve Party, engagement with surrounding schools, bingo, resident engagement, secured dollars per unit per year funds, partnerships with local organizations, food distributions, Walking School Bus, social media, yard sales, newsletters, brochures, and others.

Some of the proposed plans include creating book clubs, dance clubs, health clubs, art classes, cooking classes, computer classes, resource fairs, education and job training classes, health

classes, community stores, holiday events and others.

Today, we will hear from three Resident Councils as they share some of the successes in their communities and some of the ideas that they have moving forward.

#### SUMMARY:

The Community Development Initiatives Department's work is largely focused on fulfilling SAHA's first strategic goal to "empower and equip families to improve their quality of life and achieve economic stability." To accomplish this, staff works with outside agencies to provide resources and services to our clients. Throughout the year, CDI host events and classes not only to educate residents, but also to bring attention to resident challenges. Over 50% of SAHA head of households are elderly and/or disabled. Some residents are challenged by having limited sight or are completely blind.

The National Federation of the Blind has designated October 15th of each year as White Cane Day for the last fifty-four years. In San Antonio, the event has been hosted for the last six years. This year, SAHA will host this event in the Central Office park on October 15, 2019, from 11:00 a.m. to 2:00 p.m. The partners that are actively working on planning this event include Alamo Council for the Blind, The Blind Veterans Association, City of San Antonio's Disability Access Office, the Guide Dogs of Texas, the Lighthouse for the Blind, the National Federation for the Blind, VIA, and Texas Workforce Commission.

While it was not uncommon throughout history for blind people to use a stick or cane to navigate, society largely didn't accept that blind people could travel by themselves until recently. The United States Congress adopted a joint resolution in 1964, designating October 15 of each year as White Cane Safety Day and recognizing that white canes enable blind people to travel safely and independently.

While the white cane does keep blind people safe (because drivers and other pedestrians can easily see it), it is also a tool that blind people use to explore and navigate our environment. For this reason, the emphasis of White Cane Safety Day has shifted over time away from safety, and toward independence and equality. The event is used to celebrate this history and recognize the white cane as the tool that allows the blind to "come and go on [our] own" as President Lyndon Johnson said back in 1964.

To emphasize the shift in focus from safety to independence, and to continue to use the white cane as a symbol, we have chosen to refer to this day as White Cane Awareness Day.

#### SUMMARY:

The Community Development Initiatives Department's work is largely focused on fulfilling SAHA's first strategic goal to "empower and equip families to improve their quality of life and achieve economic stability." A large part of the work is focussed on head of households; however, many activities and events are geared towards children. Over 50% of the residents SAHA serves are under the age of 18. In recent years, the Policy and Planning Department had secured data sharing agreements with local school districts.

SAHA and the San Antonio Independent School District (SAISD) have over 6,000 shared youth in kindergarten through 12th grade. Approximately 12% of the 50,000 SAISD students live in SAHA assisted housing and 30% of SAHA assisted housing students attend SAISD schools. In school year 2016-2017, over 2,200 SAHA students were enrolled in thirteen Lanier High School feeder schools and over 44% of these students were chronically absent (P16 Plus). Approximately 14% of our SAISD students have missed 21 days or more.

Recognizing that chronic absenteeism is a powerful indicator of families in crisis, SAHA has joined an external collaborative stakeholder group, the SAHA-SAISD Task-Force, as an opportunity to strengthen relationships between schools, community agencies, students and their families. By addressing and removing barriers to school attendance, SAHA can ensure that children are ready to succeed in school and life.

The Task-Force is comprised of SAHA, SAISD, Communities-In-Schools, City Year, Bexar County Truancy Court, and others. SAHA and SAISD provide very different services, yet they share a common clientele and desire to ensure that low-income children have equal access to educational opportunities. The Task-Force's explicit investment and emphasis on systems-level collaboration is unique, as it aims to target factors that increase chronic absenteeism among youth in housing.

For the last year, SAHA has been applying for grants to secure resources to hire an attendance coordinator to address this issue. SAHA has applied for the following grants:

While CDI awaits the results of the two remaining grant proposals, CDI partnered with the Municipal Court System in January to initiate a pilot program. The Attendance Partnership (AP) Pilot program is a truancy intervention program with the City of San Antonio Municipal Court. The AP program aims to reduce truancy by linking truant students and their families to services through case management. The intervention's underlying assumption is that truancy is not merely a reflection of the individual student, but is often rooted in the family and family needs. The expectation; therefore, is that providing services to address family needs and improve family well-being can be an effective way to reduce truancy.

Under the direction of CDI, the AP is a partnership among SAHA, City of San Antonio Municipal Court, SAISD, and Sarah King Elementary. Due to its proximity to Cassiano Homes, large number of SAHA students, and high number of chronically absent SAHA students, the AP program is being piloted at Sarah King Elementary, In January of 2019, Sarah King Elementary had the second highest chronic absenteeism rates among elementary schools in SAISD.
