RESOLUTION 6023, AUTHORIZING THE SAN ANTONIO HOUSING AUTHORITY PRESIDENT AND CEO, WITH THE ADVICE AND CONSENT OF THE BOARD CHAIR, TO PERFORM EMERGENCY ACTION FOR BOARD-APPROVED OPERATIONS



REQUESTED ACTION:

Consideration and approval regarding Resolution 6023, authorizing the San Antonio Housing Authority President and CEO, with the advice and consent of the Board Chair, to perform Emergency Action for Board-approved Operations.

FINANCIAL IMPACT:

Emergency Action for Board-approved Operations will be funded by operating budgets, MTW funds, and/or available reserves.

SUMMARY:

On March 13, 2020, the President of the United States declared a national emergency concerning the Novel Coronavirus Disease (COVID-19) Outbreak, noting that State and local governments are taking preventive and proactive measures to slow the spread of the virus.

On March 19, 2020, the Governor of the State of Texas issued Executive Orders that went into effect March 20, 2020, to mitigate the spread of COVID-19 in Texas by limiting public gatherings to help reduce exposure for people across the State. The Governor declared a public health disaster in the State of Texas.

On March 23, 2020, Bexar County Judge Nelson Wolff and San Antonio Mayor Ron Nirenberg issued stay-at-home orders that went into effect on Tuesday, March 24, 2020.

The San Antonio Housing Authority (SAHA) has taken, and will continue to take, precautionary measures to limit person-to-person interactions as recommended by the Centers for Disease Control and Prevention (CDC), including measures to protect the health and safety of our residents, staff, and the larger San Antonio community.

SAHA is authorized by Texas Local Government Code Chapter 392 (the "Housing Authorities Laws"), specifically Section 392.051(a), to exercise public and essential governmental functions with the powers necessary or convenient to accomplish the purposes and provisions of Chapter 392. Section 392.051(c) allows SAHA to delegate a power or duty to an agent or employee as it considers proper.

This action will delegate to the President and CEO, working with the advice and consent of the Board Chair, the authority for "Emergency Action for Board-approved Operations" (i.e., items

normally approved by a quorum of the full Board of Commissioners), including executing all necessary documents and contracts, purchasing all goods and services, and taking any and all other actions on SAHA's behalf related to such Emergency Action for Board-approved Operations.

The SAHA Board of Commissioners wish to maintain this delegation (i) for as long as the President, the Governor, the City Mayor or the County Judge continue to declare the COVID-19 outbreak an emergency or a disaster and issue orders related thereto or (ii) until this resolution is rescinded by the Board.

SAHA will continue to hold monthly Regular Board meetings using remote access technologies regardless of the delegation.

WHEREAS, on March 23, 2020, Bexar County Judge Nelson Wolff and San Antonio Mayor Ron Nirenberg issued stay-at-home orders that went into effect on Tuesday, March 24, 2020; and

WHEREAS, the San Antonio Housing Authority (SAHA) has taken, and will continue to take, precautionary measures to limit person-to-person interactions as recommended by the Centers for Disease Control and Prevention (CDC), including measures to protect the health and safety of our residents, staff, and the larger San Antonio community; and

WHEREAS, SAHA is authorized by Texas Local Government Code Chapter 392 (the "Housing Authorities Laws"), specifically Section 392.051(a), to exercise public and essential governmental functions with the powers necessary or convenient to accomplish the purposes and provisions of Chapter 392; and

WHEREAS, SAHA is authorized by the Housing Authorities Laws, specifically Section 392.051(c) to delegate a power or duty to an agent or employee as it considers proper; and

WHEREAS, SAHA's Board of Commissioners wish to protect the public health and safety of SAHA residents, employees and officers and the community by limiting the need for public meetings or Board action for emergency or catastrophic matters or when Board committee meetings or Board meetings are infeasible; and

WHEREAS, the SAHA Board of Commissioners wish to delegate to the President & CEO, working with the advice and consent of the Board Chair, the authority for "Emergency Action for Board-approved Operations" (i.e., items normally approved by a quorum of the full Board of Commissioners), including executing all necessary documents and contracts, purchasing all goods and services, and taking any and all other actions on SAHA's behalf related to such Emergency Action for Board-approved Operations; and

WHEREAS, the SAHA Board of Commissioners wish to maintain this delegation (i) for as long as the President, the Governor, the City Mayor or the County Judge continue to declare the COVID-19 outbreak an emergency or a disaster and issue orders related thereto or (ii) until this resolution is rescinded by the Board; and

WHEREAS, SAHA will continue to hold monthly Regular Board meetings using remote access technologies regardless of the delegation herein.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of SAHA hereby:

- 1) Approves Resolution 6023, authorizing the San Antonio Housing Authority President and CEO, working with the advice and consent of the Board Chair, to perform Emergency Action for Board-approved Operations.
- 2) Authorizes the President and CEO to execute all necessary documents associated with this action.
